PAYMENT TERMS:

The room host/hostess is **ONLY** responsible for making sure food & beverages are replenished as needed, assisting with any questions, making sure bathroom is well maintained. Guests are expected to vacate the facility by the contracted end time. Any additional time before or over scheduled contracted time will be charged \$75 per hour.
